### Other terms and conditions of Tenderer

- 1. In case of any breach of agreement at any time of the part the tenderer, the agreement shall be terminated summarily by the department and penalty of 2% of the total coast of ordered Items(S) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 2. The Rates shall be quoted for Destination including loading unloading and should be inclusive of all taxes.
- 3. The supply of items to the college should be done in correspondence with College Purchasing Committee so that necessary checks and inspections are done. Further, for verification of the weight of hard coke and rejected wood, College Purchasing Committee must be conveyed in advance before loading of aforementioned items in the carrying vehicle so that the weight of vehicle before and after loading is recorded at any weight bridge suitable for college Purchasing committee.
- **4.** During the period of contract if the price of the ordered items decreases/falls the same shall be considered as final.
- 5. Disputes if any, shall be settled by the Courts with the jurisdiction of J&K Union Territory Srinagar/Jammu)
- **6.** No tender will be considered unless and until all the documents are properly signed.
- Acceptance of the items is further subject to the inspection of College Purchasing Committee whose decision shall be final and binding to consignees.
- **8.** Financial bid of only those tenderers shall be opened who will qualify the Technical bid.
- **9.** No terms and conditions of the tenderers shall be entertained by the College.
- **10.**Principal, Govt. Degree College, Ganderbal and College Purchasing Committee reserve the right to accept or reject any or all the tenders without assigning any reason thereof.
