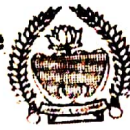

Note :- Earnest Money Deposit in the form of CDR/FDR is to be submitted by successful bidder only in favour of Principal GDC Ganderbal (J&K) for an amount equal to 5% of the bid value.

- 1 In case of any breach of agreement at any time on the part the tenderer, the agreement shall be terminated summarily by the department and penalty of 2% of the total cost of ordered Items(S) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 2 The Rates shall be quoted FOR Destination and should be inclusive of all taxes.
- 3 Items should have minimum 3 year onsite warranty.
- 4 The rates should include installation of the equipment and on-site training for the users.
- 5 The quality and quantity of the supplies shall be monitored and verified by the College Purchasing Committee.
- 6 Disputes if any, shall be settled by the Courts with the jurisdiction of J&K Union Territory Srinagar/Jammu).
- 7 No tender will be considered unless and until all the documents are properly signed and uploaded.
- 8 Delivery of the items is further subject to the inspection of College Purchase Committee whose decision regarding acceptance shall be final and binding on the supplier.
- 9 Financial bid of only those shall be opened who qualify the Technical bid.
- 10 No terms and conditions of the tenderers shall be entertained by the College.
- 11 Principal, Govt. Degree College, Ganderbal and College Purchasing Committee reserve the right to accept or reject any or all the tenders without assigning any reason thereof.
- 12 Payment shall be made after receipt of verified bills of the ordered items from the supplier.
- 13 In case of any dispute decision of College Administration shall be final.
- 14 Payment shall be released after the bills are duly recommended by the College Purchasing Committee and subject to fulfillment of terms and conditions.
- 15 The consignment shall have to be delivered by the supplier within a week's time from the date of issuance of supply order.
