Other terms and conditions of Tender

- 1 In case of any breach of agreement at any time on the part the tenderer, the agreement shall be terminated summarily by the department and penalty of 5% of the total cost of ordered Items(s) shall be imposed on the supplier and CDR/FDR shall be forfeited.
- 2 The Rates shall be quoted FOR College and should be inclusive of all taxes.
- 3 The quality and quantity of the supplies shall be monitored and verified by the College Purchase/GeM/E-Tendering Committee. Use of weigh bridge for Hard-Coke is imperative.
- 4 Disputes if any, shall be settled by the Courts within the jurisdiction of Srinagar/Ganderbal District(s) only).
- 5 No tender will be considered unless and until all the documents are properly signed and uploaded.
- 6 Delivery of the items is further subject to the inspection of College Purchase/GeM/E-Tendering Committee whose decision regarding acceptance shall be final and binding on the consignees/ indenting party.
- 7 Financial bid of only those shall be opened who qualify the Technical bid.
- 8 No terms and conditions of the tenderers shall be entertained by the College.
