### Terms and conditions for the College Canteen

01. The canteen shall remain open from 9am to 5pm on all working days. It will also remain open on Sunday during IGNOU hours and for the examination days even if these fall on holidays and will remain closed on all Gazette Holiday.
02. The Canteen contractor is not permitted to sell any narcotics (smoking items) and beverages including carbonated drinks which stand banned by Supreme Court.
03. Smoking in no case is permitted within the Canteen premises and punishable under Law.
04. The rate list of the approved items must be displaced on the wall of the Canteen.
05. The Canteen Contractor is not permitted to sell any other items other than the items approved by the College Canteen Committee.
06. The Canteen Contractor is personally responsible for the security of all items including furniture and other fixture in the canteen.
07. The canteen will remain under the vigil of canteen committee/Principal and any untoward incidents will be dealt firmly in accordance with the Law.
08. The Canteen contractor shall cater to all the department of the College whenever required.
09. The contractor has to pay Rs. 5000/- as monthly rent and to this effect an advance rent of (06) six months shall have to be deposited in the College chest before starting the canteen.
10. Displaying obscene/Pictures/Hoardings shall not be allowed in the Canteen premises.
11. The Canteen contractor shall have to arrange himself any furniture/fixture, if any, required for the efficient running of Canteen.
12. The Canteen contractor has to handover the College property back to College authorities after the completion of term.
13. The contractor shall have to maintain cleanness in and around the Canteen.
14. The submission of tender will automatically mean that you will abide by all the rules and regulations of the College along with the conditions as laid down in the tender notice.
15. The College has right to delete/include any item at any time.
16. The undersigned have every right to reject any tender without assigning any reason thereof.
17. Use of Polythene/Plastic bottles is banned in the College Campus.
