


Minutes of meeting

2019

A meeting was convened on 14-05-2019 in the Principal Chamber with Principal Sir in the Chair to revisit the decisions taken in the meeting held on 20-04-2019 for discussion in light of the Govt. order received from Higher Education department vide No. 272-HE of 2019 dated 13-05-2019 where under the College has been authorized to meet out the expenditure to the tune of Rs.15.0 lac (Rupees fifteen lac only) out of local fund to be incurred on the eve of NAAC Peer Team visit scheduled on 19-20 June 2019. In the meeting, the members opened the decisions made in the early meeting for discussion and felt that these may be amended in light of the said Govt. Order. After having fresh discussion on the subject, the members unanimously resolved that following tasks may be taken up for execution with immediate effect:-

1. Repair/Renovation of Bathrooms/Urinals
2. Minor Facelift of the college premises and various structures of the College.
3. Minor Repairing of Computers and UPS Systems in various Departments.
4. Maintenance of Rock Garden/Botanical Garden/Herbal Garden.
5. Landscape development of College Campus.
6. Repair/renovation of labs/Museum and purchase of lab equipment/infrastructure.
7. Erecting/Installation of information/instruction boards across the College Campus.
8. Restoration of Electricity across College campus.
9. Repair/renovation of parking space.
10. Fixing of Glass Pans in the windows of various structures.
11. Purchase of Furniture/furnishing/Curtains in various departments/canteen.
12. Upgradation of I.T/Sports/Gym facilities available in the College.
13. Cleanliness drive across College Campuses including interior structures.
14. The arrangement in respect of protocol shall be managed by protocol committee of the College on need basis.

Further, during the meeting it came into limelight that due to late issuance of the said Govt. Order, the time left with the College to take up these works is limited (twenty to twenty five days only) and the tendering process at this stage is not possible. As the works under consideration cannot be ignored or kept in abeyance for larger interest of the College and students, therefore, members came to the conclusion that these works may be taken up for execution with immediate effect and the formalities


























